- Only Tea sold in Food Vending booths. CCR reserves the right to all other beverage products including alcoholic beverages.
- We do not offer exclusive merchandise categories, however we try to limit exact duplicate items. Example: Only one Peanut Vendor, but possibly more than one jewelry vendor of different types of jewelry.
- All vendors must stay inside your vending space. No sales or solicitation outside of the space.
- **NO** Vendor will be allowed to consume **Alcoholic** beverages...
- All vendors must keep area neat and clean at all times and free of all trash upon leaving. Dumpsters are located on back of Midway.
- **ALL** Vendors must check in and receive your vendor packet before setting up.
- Vendors can only sell items inside your designated booth space and during the opening times of the event.
